RESOLUTION 61, 2015

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM BEACH GARDENS, FLORIDA APPROVING THE CITY'S ANALYSIS OF IMPEDIMENTS TO FAIR HOUSING CHOICE AND AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE THE ANALYSIS; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, 24 CFR Part 91 requires that the City of Palm Beach Gardens prepares and submits to HUD the Analysis of Impediments to Fair Housing Choice not less than once every three (3) to five (5) years to receive its formula grants; and

WHEREAS, 24 CFR Part 91 and the HUD Miami Area Office require that the Analysis of Impediments to Fair Housing Choice be duly authorized by the governing body of Palm Beach Gardens; and

WHEREAS, the Analysis of Impediments to Fair Housing Choice is attached hereto as Exhibit "A"; and

WHEREAS, the City Council deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Palm Beach Gardens and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PALM BEACH GARDENS, FLORIDA that:


SECTION 1. The foregoing recitals are hereby affirmed and ratified.


