RESOLUTION 28, 2015

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM BEACH GARDENS, FLORIDA APPROVING THE PALM BEACH GARDENS FIVE- (5) YEAR CONSOLIDATED PLAN FOR 2015-2019, INCLUSIVE OF THE CITIZEN PARTICIPATION PLAN AND YEAR-ONE ACTION PLAN; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, 24 CFR Part 91 requires that Palm Beach Gardens prepares and submits to the U.S. Department of Housing and Urban Development (HUD) the Consolidated Plan, inclusive of the Citizen Participation Plan and Year-One Action Plan, and a Consolidated Plan not less than once every five (5) years to receive its formula grants; and

WHEREAS, preparation of these documents is a prerequisite for receiving funding under the CDBG Program; and

WHEREAS, HUD requires that these documents be signed by the City's Administrator; and

WHEREAS, 24 CFR Part 91, and the HUD Miami Area Office require that the Five (5)-Year Consolidated Plan, inclusive of the Citizen Participation Plan, and Year-One Action Plan be duly authorized by the governing body of Palm Beach Gardens; and

WHEREAS, the City Council deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Palm Beach Gardens and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PALM BEACH GARDENS, FLORIDA that:

SECTION 1. The foregoing recitals are hereby affirmed and ratified.

SECTION 2. The Five- (5) Year Consolidated Plan for FY 2015-2019, inclusive of the Citizen Participation Plan and the Year-One Action Plan be approved and executed for submission to HUD.

SECTION 3. This petition is approved subject to strict compliance with the Exhibits listed below, which are attached hereto and made a part hereof as Exhibit "A":

1. The Consolidated Plan, Inclusive of the Citizen Participation Plan and Year-One (1) Action Plan, prepared by *Carras Community Investment, Inc.*, dated August 2015.

SECTION 4. This Resolution shall become effective immediately upon adoption.


